

# Program Highlights

---

This year's program promises to be a lesson in how we work together and with others to collect, preserve, and disseminate the historical record. The plenary and luncheon speakers reflect how the archival community is a part of its geographic location as well as how it cooperates and interacts with other fields to further each other's goals.

The sessions range from the nitty-gritty of a collection survey at Bancroft Library to the collaborations and arrangements made with donors and others to bring in and develop collections with statewide, national, and international significance. We'll hear about technological issues including web archiving, moving image collections, and collection management software. On the user side we'll learn about working with the National History Day researcher, spreading the word with the LA as Subject Archives Bazaar, and engaging with artists, writers, and other non-traditional users.

On the allied professions side, a panel of cultural heritage service providers will share how their non-traditional collaborations have heightened interest in Riverside's heritage, we'll discuss the intersection of libraries, archives, and museums with colleagues who are blurring those distinctions, and we'll hear from the Connecting to Collections folks who are creating a statewide preservation plan drawing upon the expertise of the archives, museum, library, and historical communities.

We encourage you to take advantage of the diverse offerings of the speakers, the sessions, the vendors in the exhibit hall, the silent auction lots, and our fellow attendees.

We take a look back at what used to be on Main Street. Our host hotel is located on what would have been Main Street between 4<sup>th</sup> and 5<sup>th</sup> Streets. The restored County Courthouse, where we will join together for the opening reception, is on Main between 10<sup>th</sup> and 12<sup>th</sup>

Joining us for the opening reception, you will walk down the Main Street pedestrian mall. Take a look at some of the buildings which are currently on the mall. The restored Loring Building at Main and Mission Inn reminds one of 19<sup>th</sup> century construction. This was originally designed as the local opera house.

We hope you have an opportunity to enjoy the shops and museums in the downtown area and perhaps venture into the "citrus streets" - Orange, Lemon and Lime - to view the historic Harada House at 3356 Lemon Street. The structure is not remarkable, but the court case which revolved around its ownership was a significant piece of civil rights adjudication.

Tours of the historic Mission Inn provide an intriguing start to the meeting this year. (Someone even managed to get free tickets to these at the Silent Auction last year.) This year the Silent Auction and Vendors will share space in the Regency Ballroom and we hope you will spend time with both. We have arranged to have our session breaks in the room to encourage your attendance.



Dinner on Friday is at the Hofer Ranch in nearby Ontario. They don't raise livestock on the ranch, but they do manage to wrangle up a pretty good grape crop which finds its way to our local wineries. This was one of the first viticulture areas in the state. If you want more information on that subject, just ask Jim Hofer. His cousin Paul owns the family ranch. Even though there won't be many cows, feel free to don your cowboy and cowgirl duds and join us for the barbeque and a bit of music.


It's been over a decade since SCA met in Riverside and we hope you enjoy this meeting as much as members did the 25<sup>th</sup> anniversary thirteen years ago.

## TRANSPORTATION

Riverside is located at the junction of the 60, 91, and 215 freeways. You will find the host hotel, the Marriott, on Market Street, between 4<sup>th</sup> and 5<sup>th</sup> Streets. Fourth Street actually serves as the entryway into the Marriott parking structure. The hotel is opposite the Convention Center.



## **TRANSPORTATION Cont.**

### **BY AIR**

Ontario International Airport serves Riverside. It is a 35 minute drive from the airport to the hotel.

**SHUTTLE SERVICE** – Contact the hotel 72 hours in advance with your flight information and tell them you are attending the SCA Annual General Meeting. This is a free service, but you must mention the name of the meeting.

### **DRIVING**

**From the Ontario Airport**, take Airport Drive east to Haven Avenue. Turn right on Haven (south) to the 60 freeway east. This is a left lane access ramp, after crossing over the freeway. Continue on the 60 east (Pomona Fwy) to the Market Street off ramp. Turn right at the bottom of the ramp and proceed past Fairmont Park to 5<sup>th</sup> Street. Turn left and the hotel entrance is on your left.

**From the West**, take your choice of freeways traveling east. The 10 (San Bernardino Fwy) east will join with the 91/215 just north of downtown Riverside. Take the 215/91 (Riverside Fwy) south to the Mission Inn Avenue off ramp. Turn right on Mission Inn and proceed to Market. Turn right on Market to 5<sup>th</sup> Street. Turn right on 5<sup>th</sup> and the hotel entrance is the first driveway on your left.

The 60 (Pomona Fwy) east has a Market Street off ramp. Turn right at the bottom of the ramp and proceed past Fairmont Park to 5<sup>th</sup> Street. Turn left and the hotel entrance is on your left.

The 210 East joins with the 15. Take the 15 south to the 60 interchange. Take the Riverside on ramp onto the 60 and proceed to the Market Street off ramp. (see above.)

**From the South**, take the 91 or 215 freeway and travel north.

The 91 (Riverside Fwy) has an off ramp at Mission Inn Avenue. Turn left on Mission Inn Avenue and proceed to Market Street. Turn right on Market to 5<sup>th</sup> Street. Turn right on 5<sup>th</sup> and the entrance to the hotel will be on your left.

The 215 joins with the 60 just prior to reaching Riverside. Continue on the 215/60 to the University Avenue off ramp. Turn right on University and continue to Market. Turn right on Market to 5<sup>th</sup> and turn right onto 5<sup>th</sup>. The Marriott entrance will be on the left.



## **TRANSPORTATION cont.**

**From the East**, take the 10 or 60 freeway and travel west.

The 10 has an interchange with the 215. Take the 215 south to the Mission Inn Avenue off ramp. Turn right on Mission Inn and travel to Market Street. Turn right on Market Street and continue to 5<sup>th</sup> Street. Turn right on 5<sup>th</sup>. The Marriott will be the first building on the left.

The 60 traveling west has an off ramp at University Avenue. Turn right on University and continue to Market. Turn right on Market to 5<sup>th</sup> and turn right onto 5<sup>th</sup>. The Marriott entrance will be on the left.

**From the North**, take the 215 freeway south to Mission Inn Avenue off ramp. Turn right on Mission Inn and travel to Market Street. Turn right on Market Street and continue to 5<sup>th</sup> Street. Turn right on 5<sup>th</sup>. The Marriott will be the first building on the left.

**PARKING** – Parking is available at the covered parking structure adjacent to the hotel for \$8.00 per day.

## **Cultivating the Collaboration Fields**

In February 2008, with foundation grant funds from the Mellon and Rosalinde and Arthur Gilbert Foundations, the Bancroft Library hired four archivists to survey the Bancroft's entire manuscript collection of approximately 55,000 linear feet—or roughly ten miles of holdings. The survey archivists and the project supervisor will introduce the survey, summarizing why it was needed, the



planning and preparation done for the survey, how it was originally envisioned, and the actual day-to-day workings of the survey, including how the workflow has deviated from what was envisioned, the tools used, and the challenges encountered. The presentation will also include a slide show of gems from The Bancroft's collections and conclude with a few useful tips for repositories contemplating mounting a survey of their own.

## **Session 2: From Vault to Computer/TV Screen: Sharing Your Moving Image Treasures with the Whole World**

All archival repositories have moving image collections: some are extensive and include thousands of items, others contain just several dozen videotapes. How can archives make these treasures accessible for archival users on their personal or classroom computers? Do video sharing sites and DVD-on-demand services satisfy outreach, reference, publicity, and access demands? Archivists from three diverse institutions will share their experiences using Amazon, the Internet Archive, and YouTube to disseminate their videos. This session will also discuss current developments in the fields of moving image preservation, digitization, cataloguing, and copyright.

**Archimedes: Ancient Text Revealed with X-ray Vision**

Archimedes of Syracuse (287 - 212 BC) is considered one of the most brilliant thinkers of all times. The 10<sup>th</sup>-century parchment document known as the Archimedes Palimpsest is the oldest surviving copy of his work. Much of the writings have been imaged by various optical techniques, but on some pages and passages these methods failed. A breakthrough in uncovering the missing writings has recently been achieved at Stanford, with a technique called x-ray fluorescence imaging. Please join Uwe Bergmann in a fascinating journey of a 1000 year old parchment from its origin in Constantinople to a particle accelerator in Menlo Park, California. Uwe Bergmann is a physicist at the SLAC National Accelerator Laboratory whose interest is in the development and application of novel synchrotron-based x-ray techniques.

Increasingly, National History Day students have been contacting archival repositories. They are uncertain about archives and more than a little intimidated by the structure and the rules of the research room. However, they are a large group of researchers, who could become lifelong patrons. For archives and archivists, this is a community of researchers that is uniquely oriented toward what we do. NHD requires that students utilize primary source materials in their projects.

Many archivists have expressed a desire to work with these students, but don't know how to address such young researchers (most are 12-18 years of age) and in fact, many archives don't allow children to research at all. This panel will attempt to demystify the NHD competition with a focus on the role that primary sources play. The session will present strategies from archivists who have successfully integrated the NHD student into their research rooms.



Panelists will take a look at how libraries, archives, and museums interact and collaborate when they are in the same institution. The challenges faced by archives and libraries that are within museums and how they deal with those problems will be addressed. The session will highlight specific institutions that have taken steps to unify their LAM aspects including collection management and other policies, procedure manual, an integrated website, and a search portal that allows searches across a variety of institutional systems.

#### **Session 8: Strangers in a Strange Land: Collaborating with Donors to Bring in and Develop Major Collections**

The speakers will present case studies on collaborations and arrangements made with donors and others to bring in and develop collections with statewide, national and international significance. The title Strangers in a Strange Land (referencing Robert A. Heinlein science fiction book) connotes an image of Special Collections staff operating in a strange world of publicists, attorneys, and literary rights executors, while donors and their representatives must operate in an unfamiliar world of research libraries with their requirements. Featured collections include the Michael and Margaret B. Harrison Western Research Collection and the Gary Snyder Papers, University of California, Davis; the John Muir Papers and the Brubeck Collection, University of the Pacific; and the Robert A. and Virginia G. Heinlein Papers, University of California, Santa Cruz.


## Session 10: Records and the Law: A Review of Recent Legislation Impacting the Archival Profession

Topics include: Preserving the American Historical Record (PAHR) campaigns; recent federal and state legislation effecting archivists such as the Health Insurance Portability and Accountability Act or HIPAA; and a discussion of the day-to-day realities of complying with the new redaction law, as well as providing information on the state replevin legislation.

A fascination and engagement with historical materials by artists and writers has fueled many recent international art projects, ranging from public and conceptual art installations, to live performances, to the creation of historical geographies. Writers have taken archives as conceptual and literal points of departure for fictional histories, particularly "recovered" histories of people generally absent from the historical record. The incorporation of archival collections into the creative process requires archivists and their institutions to think differently about the use of our resources, and the role of archivists as facilitators between their institutions and this emerging audience. Panelists will examine some of their engagements with artists, writers and other non-traditional users, with an eye toward exploring what they are seeking from their institutions, how artists and writers view the archives and archivists, and how we can meet them as collaborators and supporters of these new works.

## Session 12: Short Attention Span Theater

Can't sit still for a whole session? Want to mix it up with other attendees on a variety of topics? This is a more active session with groups centered around several topics. Participants have the opportunity to choose a group: topic a, topic b, topic c, etc. For 20 minutes, that group of 5-8 people will discuss the topic, facilitated by an expert on the issue.
